Chairman's Review of 2012

2012 has been an arduous year for the Society. A number of important challenges faced us at the time when the Executive was numerically at its weakest. It is for this reason, at the beginning of this report, that I would like to thank the five members of the Executive, who put in such hard work.

We have spent a good deal of time considering our strategy and how we might best accomplish our aims for the benefit of the town. An intrinsic problem is that our concern is for the town as a whole, which can sometimes become generalized and diffused and this may contrast unfavourably, with the aims of single-issue groups, whose concerns are narrower and more focused. Much of our effort is spent in arguing a case and lobbying for change; the outcome of this effort can be difficult to evaluate and might not bear fruit for some time. However, this must continue, whatever the outcome.

Contrasted with this is work done in support of individual schemes. In this context, things have changed over the last year or two, new focus-groups have been set up to concentrate on specific issues and the Society works also through them. Friends of Pontefract Park, Friends of the Friarwood Valley Gardens, and Pontefract Dispensary and Hermitage Action Group are all organisations, within which the Society is heavily involved, and whose aims are specific and focused. We feel though, that there is still an opportunity for us to deliver small public realm schemes in the town, which will greatly improve its attractiveness.

The Society has been delighted to receive a substantial legacy from the estate of our former Treasurer Malcolm Macaskill and this should help us in delivering small schemes to the benefit of the town and in memory of him.

We have been very fortunate in being able to welcome on to the Executive during the year, our new Treasurer, Stephen Lofthouse and Dr Colin White who is very active in other groups also. This has very much strengthened our hand.

Details of our activity will be found elsewhere in the committee reports and will not be repeated here, but there are larger concerns that will exercise our minds also. The recent announcement that Tesco's are pulling out of a £40m development in town will affect the contingent development of Tanshelf, and the continuing lack of investment in the town as a whole is also a concern.



The Authority is attempting to advance the development of the Prince of Wales site, and we should find out within the next year or so whether funding bids will have been successful.

There is obviously much to do in the next year and the Society will continue to do its work on behalf of the town.

It remains for me now to emphasise that the Society is more than simply the Executive and I should like to thank all who have worked in any capacity to help our cause – but not forgetting those, who for various reasons, are unable to give practical help but simply support us. All are valued.

Once I become more familiar with the Society, I'll be able to comment more fully, in future publications, though I feel member recruitment is a key issue.

Conservation, Environment & Planning Committee Report

One of the roles of the Society and particularly the CEP Committee is to monitor alterations and changes which occur within the town centre, with reference to buildings contributing to its historic and townscape character.

Quality design can contribute to an interesting environment and economic success.

There have been no major new buildings and only a few redevelopment schemes within the town centre in the year, but numerous small changes, not always requiring planning approval.

Replacement of signage, repainting of upper facades and roof repairs has in their small way contributed to at least maintaining a reasonably attractive town.

The planning process is undergoing significant changes aiming to stimulate the economy. It would appear that these are unlikely to affect development in the Conservation Area or Listed Buildings. Comments made on planning applications have resulted in proposals being withdrawn or modified before being granted approval by the local authority.



The Society seeks to encourage and enhance redevelopment schemes, not just to criticise.

The CEP Committee continues to monitor changes and looks to promoting the high quality development the historic centre deserves.

New ideas and future activities are considered and discussed with Conservation Officers from the local authority, attendance at meetings of YAHCS and contacts with other Civic Societies are maintained.

The CEP Committee assisted in producing a Mary Portas bid for monies to enhance the town centre. Part of this bid involved the idea of adding 'colour' to the upper facades of buildings. Although unsuccessful at the first attempt, a small grant has been awarded WMDC & the Town Centre Partnership to assist in improving the market stall hoardings.



The appointment of a permanent Townscape Heritage Initiative Officer will bring some rewards in the future. A great deal of background work has been done but the economic situation, lease agreements and absentee landlords are hindering progress. Any obvious changes may be small but in accumulation can lead to significant improvements.

I would like to thank members of the CEP Committee for their help, enthusiasm and interest in contributing to the Civic Society's aims in relation to the town.

Land Use & Transport Committee Report

Under the Local Authority's Local Development Framework (LDF) several sites in Pontefract have been earmarked for substantial housing development and three of these have been prominent in the public mind over the last year. Two of these sites: Hardwick Road/Ackworth Road and Cobblers Lane have predictably been opposed by local residents, mainly on the grounds of traffic congestion and the development of virgin land. Development of the third site - the former Prince of Wales Colliery - is, by contrast, generally supported because it would transform a derelict brownfield site into an attractive residential part of the town. The problem is that the sites the public least want to see developed are easier to deliver and the one that receives the most support is the hardest to deliver, but all present problems for our road system.



Town End, where all the major routes through Pontefract converge, remains an almost intractable problem. The solution of replacing the traffic light system by a double (unequal) roundabout system has

been accepted, but detail design work is proving awkward and the final outcome may not be much better than the status quo, especially at peak times. The Society supports the stance taken by SELRAG in advocating the resurrection of the link road from the end of the Hemsworth Bypass to the M62 (Jn31) via Brackenhill, Went Lane and the A645 junction at LinPac. This 30-year-old proposal creates a new North/South route through the district and has the virtue, not only of reducing the traffic flow through Pontefract, but of easing problems in Ackworth and Featherstone also - though at the expense of extra pressure on Jn31. In the short term, solutions in Pontefract have to concentrate on dilution of traffic flows so that traffic can be spread around more and ease congestion at pinch-points such as Town End. To this end various junction improvements to the A645 have been proposed by WMDC; these include those at Baghill Lane and Tanners Row, but the Society believes that those at Friarwood Lane/Station Lane and at Cobblers Lane/Water Lane should be added. In addition, improvements to the junctions of Mill Dam Lane with North Baileygate and also with Ferrybridge Road are also proposed in connection with the development of a new road from Jn32 to Monkhill, north of and parallel to the railway line. The Society has taken a particular interest in the road pattern of the Monkhill area in connection with the delivery of the Prince of Wales site and the need to improve transport connectivity for Pontefract. Improvements at this level will much depend on the Authority's success in attracting external regeneration funding from government sources.

In the context of rail transport the situation in Pontefract remains very unsatisfactory. The Society has presented its own plan for Monkhill station, which received widespread support, but delivery of material improvements has been very slow. The building of Glasshoughton station, while obviously needed to service the Freeport/Xscape complex, has had a very damaging effect on Monkhill in reducing the footfall there. A survey by the Society showed that over half the people using that station came from Pontefract, having been (understandably) attracted by the safe, free car parking, but this has weakened the financial case for developing Monkhill, which is desperately needed. There is a plan for improving the car park there but it is being revised at present and will be dependent on the soundness of its business case.



News of the proposed improvement of service by extending the current Wakefield Kirkgate service through to Westgate and Leeds is a little more encouraging, in that Metro regard this as a high priority, with a very good economic case to support it and it is hoped that this may be in place by 2014. However, the financial case is not so strong and the improvement would require extra subsidy, which is the obstacle to be overcome. We remain convinced that the

Society's plan for bringing bus and rail services together at Monkhill is essential for the proper working of public transport in the town and we will continue to advocate this.

There is nothing to report on possible service enhancement through the district to destinations outside West Yorkshire, as service development has been caught up in re-franchising problems and the existing franchises will remain in force for longer than anticipated; however, the Society will keep these matters under review.

The Society donated £100 to enable the Friends Group to open a bank account, and they've been supported by Christine Cartwright, as a Committee member.

What is evident from attendance at our Talks is that we get varied support, and we'd like to see more Members and Nonmembers participating.



After our 2011 visit to Selby, we entertained Selby Civic Society in 2012 with a walking tour commencing at the Anglo Saxon origins of Pontefract, moving through to the Castle and up into the town centre. Our visitors were delighted with the tour provided by Peter Cookson, supported by Allan Blaza and myself.

Both our March Annual General Meeting and the September Extraordinary General Meeting were lively affairs.

In June and July, exchange visits were made with Market Weighton Civic Society, with each group enjoying each other's towns.
